The Rwanda Environment Management Authority (REMA) has received/has applied for/intends to apply for financing from the World Bank toward the cost of the Second Urban Development Project RUDP II, and intends to apply part of the proceeds toward payments under the contract for Construction works and landscaping restoration activities for Gikondo, Rugenge-Rwintare, Nyabugogo, and Kibumba Wetlands in the City of Kigali. "For this contract the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing,"

The Rwanda Environment Management Authority (REMA) now invites eligible bidders for construction works and landscaping restoration activities for Gikondo, Rugenge-Rwintare, Nyabugogo, and Kibumba wetlands in the City of Kigali, Rwanda. The construction works include the site mobilization works, hydraulic works, landscaping activities and the construction of public restrooms. The work is planned to start by 1st November 2023 and will end on 30<sup>th</sup> October 2025.
3. The construction works & landscaping restoration activities for the Gikondo, Nyabugogo, Kibumba and Rugenge-Rwintare Wetlands in the City of Kigali.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers-" [insert date of applicable Procurement Regulations edition as per legal agreement] ("Procurement Regulations"), and is open to all eligible Bidders.

8. All Bids must be accompanied by a "Bid Security" of **220,816,000 RWF or 188,900 USD** issued by the Bank only.
9. A compulsory site visit is scheduled on **22-23 August 2023** and departure Place is at REMA Head Office at 10:00 am Local Time or 8:00 GMT.
10. All Bids must be accompanied by a Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH) Declaration.
